








Roadway and Active Transportation Revenues by Tier



Transit Revenues by Tier




Future Study Revenues by Tier

Goals, Objectives, and Performance Measures

Economic Development. Promote economic development by enhancing access to locations primed for growth.

Objective 1. Align transportation improvements with the Lake Havasu City General Plan to foster economic development.

Performance Measure: Project improves multimodal access to a General-Plan-identified growth area.

Safety. Promote safe transportation by reducing fatal and serious injury crashes.

Objective 1. Improve infrastructure at locations with severe crashes.

Performance Measure: Monetary value of crashes in the project area.

Objective 2. Improve infrastructure at locations with safety concerns for Vulnerable Road Users.

Performance Measure: Monetary value of pedestrian- and bicycle-involved crashes in the project area.



Goals, Objectives, and Performance Measures

Connectivity. Enhance connectivity and accessibility to key destinations for all modes of travel.

Objective 1. Improve multimodal access to key destinations

Performance Measure: Number of activity centers within $\frac{1}{4}$ mile of the project multiplied by the number of modes improved with the project.

Objective 2. Address transportation barriers in disadvantaged areas.

Performance Measure: Average equity score of Census block groups in the project area.

Multimodal Integration. Expand safe and accessible walking, biking, and transit options for people of all ages and abilities.

Objective 1. Promote the expansion of active transportation and transit as practical transportation options.

Performance Measure: Number of gaps the project fills in the existing bicycle and pedestrian network.



Goals, Objectives, and Performance Measures

Congestion Relief. Reduce congestion by implementing context-appropriate capacity enhancements.

Objective 1. Invest in capacity improvements in areas with significant congestion today.

Performance Measure: Existing level of service from the regional travel demand model.

Objective 2. Invest in capacity improvements in areas with congestion predicted in the future.

Performance Measure: Change in anticipated delay in the project area with and without the project in the 2050 regional travel demand model.



Goals, Objectives, and Performance Measures

Sustainability. Support community resiliency through environmentally conscious transportation improvements.

Objective 1. Invest in recommendations that do not negatively impact the region's hydrology.

Performance Measure: Whether the project is within a FEMA-designated floodplain or impacts Water of the United States

Objective 2. Invest in recommendations that do not negatively impact protected species.

Performance Measure: Number of critical habitats potentially impacted by the project

Maintenance. Maintain a safe, reliable transportation system through regular maintenance and preservation.

Objective 1. Improve areas with poor pavement conditions.

Performance Measure: Pavement condition score

Objective 2. Improve bridges with fair or poor condition.

Performance measure: Bridge condition score



Goals, Objectives, and Performance Measures

Implementation. Support transportation improvements that can be realistically implemented and are supported by the public and stakeholders.

Objective 1. Invest in cost-effective solutions.

Performance Measure: Improvement cost per mile or intersection.

Objective 2. Advance projects that are within existing right-of-way.

Performance Measure: Project does not require additional right-of-way.

Objective 3. Advance projects that are supported by member agencies.

Performance Measure: Number of upvotes for the project by the LHMPO Technical Advisory Committee.

Objective 4. Advance projects that are supported by the public.

Performance Measure: Number of comments from the first round of public engagement web map.
