- 8. Transportation Alternatives (TA) Grant Award Announcement-(Informational)
  Justin Hembree, LHMPO Director, announced to the TAC that the TA grant award scoping project has been tentatively approved.
- 9. Signal Analysis & Modeling Study-(Informational)

Justin Hembree, LHMPO Director updated the TAC on the signed PSA contract of the Signal analysis & modeling study. The notice to proceed has been sent to Kimley-Horn, and the MPO is working on the stakeholder's list for the kick-off meeting.

#### 10. Carbson Reduction Program (CRP) -(Informational)

Justin Hembree, LHMPO Director reminded the TAC on the call for projects for the Carbon Reduction Program. CRP is a federal-aid highway funding program that funds projects designed to reduce transportation emissions. He explained the LHMPO apportionment for the area which is \$448.513.01 and gave examples of projects identified by the City the funds can be used for. Local agencies to submit CRP project applications to the MPO by March 15, 2024.

Subject: ADOT MPD Report

- **1. FY25-29 Five-Year Construction Program:** District workshops were completed in the month of September. The P2P manager is working on incorporating workshop comments & project updates into the P2P List. The P2P process will prioritize all highway construction projects for consideration in ADOT's FY 2025-2029 Five-Year Construction Program.
- **2**. **ADOT SMART Program:** Please continue to work with your local agencies to submit any applications for the SMART program. The website continues to be the host of useful information found at <a href="https://azdot.gov/planning/grant-coordination/az-smart-fund">https://azdot.gov/planning/grant-coordination/az-smart-fund</a>.
- **3. Federal Discretionary Grants:** Please continue to visit USDOT's website or the ADOT grant coordination page <a href="https://azdot.gov/planning/adot-grant-coordination-group">https://azdot.gov/planning/adot-grant-coordination-group</a> for the NOFOs and deadlines.
- **4. TA Program:** The recommended list of projects was reviewed by the TAC on October 25th and will go to the State Transportation Board on November 17th. Please continue to visit the program website at <a href="https://activetransportation.az.gov/transportation-alternatives-program">https://activetransportation.az.gov/transportation-alternatives-program</a>. The website has a recorded webinar, guidance, FAQs, and links to the application.

5. **Off-System Bridge Programs:** The call for projects has been sent out from ADOT LPA and applications will be due December 30th. The Casa Gr Canal Ext Br in Coolidge is listed as a high-priority project to include per FHWA and ADOT staff has notified the local agencies of other priority OSB bridges.

#### Status of ADOT studies:

#### 1. Long Range Transportation Plan:

The LRTP was passed by the STB on 10/20/2023. For the review of the draft, LRTP ADOT received over 120 responses and 485 individual comments. In addition, at the 8/22/23 Statewide Virtual Meeting, 67 people attended and submitted 73 comments and questions. Public comments were reviewed and the draft went to the Governor's Office, ADOT Executive Leadership, and the STB mid-September. Please visit the ADOT LRTP webpage <a href="https://www.adot2050plan.com">https://www.adot2050plan.com</a> which hosts the plan documentation, and summary sheets (2-3 page bullet point reports of said working papers) and to provide comments.

- 2. **Electric Vehicle Infrastructure Plan:** The annual update of the NEVI plan received approval on September 30th as required per the Joint Office of Energy and Transportation. ADOT will be looking at conducting RFPs later this year or into 2024. - 3. The **Statewide Truck Parking Plan:** The last stakeholder meeting occurred on October 3rd to discuss the undesignated parking analysis, implementation strategies, possible alternative materials for paving, and locations for potential truck parking expansions/conversions at existing ADOT facilities. The final report should be complete by the end of November 2023.
- 4. **Statewide ITS Architecture Update:** The prior 2018 project lists have been sent to local agencies for any updates to be implemented in the project list, with a few follow-ups to local agencies. ADOT provided its own project updates to the consultant from the last 2018 effort with new ones to be added in from the new ITS master plan. The data collection and interface reports were delivered to the ADOT project management team for review while looking at having the next stakeholder meeting on January 11th.



We will discuss the ADOT call for HSIP projects at the upcoming January 23 Technical Advisory Committee (TAC) meeting.

Attached you will find the timeline for the FY27-28 call for projects, which outlines critical due dates. In addition, you will find a calendar invite to an upcoming ADOT webinar (<a href="https://meet.google.com/dsz-ycjf-mnp?hs=224">https://meet.google.com/dsz-ycjf-mnp?hs=224</a>) scheduled for January 18, 2024, to review the FY27-28 application requirements and overall updates to the program.

Notable FY27 & 28 HSIP program changes include:

- Updated project naming conventions as defined in Appendix E of the updated HSIP manual.
- A preliminary project review and adjustment will begin on August 19, 2024, and will be performed by an ADOT consultant in coordination with the submitting agency.
- Minimum design cost of \$150,000 and minimum construction cost of \$500,000.

To All Districts, RTES, COG/MPO and Tribal Transportation Partners:

The Arizona Department of Transportation (ADOT) Traffic Safety Section issuing a formal call for Highway Safety Improvement Program (HSIP) safety projects for SFY27 & SFY28 HSIP projects. Please distribute this message to your member agencies.

The call for projects is in support of the Transportation Performance Management (TPM) and the Arizona Strategic Traffic Safety Plan (STSP). To this end, the new call for projects will again focus on reducing fatalities and serious injuries on all public roads, projects submitted will be prioritized for statewide HSIP funds.

#### Changes to the HSIP Program (See HSIP Appendix A for details):

- FHWA project naming convention added (Appendix E)
- All potential applications will be reviewed by ADOT consultant and the consultant's fee has been added to the cost estimate
- ADOT will set-aside HSIP funds to cover potential construction cost increases on local 100% HSIP projects
- Design consultant's cost must be at least \$150,000 and the above the line construction phase must be at least \$500,000
- Arizona Tribal Safety Infrastructure Program (ATSIP) has been added
- Construction contingency has been increased to 40%

Anticipated HSIP Available Funds by FY: As of January 4, 2024

SFY27: \$32,700,000.00 SFY28: \$56,100,000.00

Below are the key dates for HSIP eligibility. (Detailed list of dates is on the HSIP webpage.)

- 1. An HSIP Webinar is scheduled for January 18, 2024, from 1:00 PM to 2:30 PM (Google Meet invitation attached to this email)
- 2. Preliminary/Draft HSIP Applications due to COG/MPO no later than COB May 1, 2024
- 3. Preliminary/Draft HSIP Applications due to ADOT no later than COB May 3, 2024 \* MUST BE SUBMITTED THROUGH THE COG/MPO.
- 4. Scoping review by ADOT Consultant August 19, 2024 Consultant will meet with local agencies between August & December to refine/finalize the scope and begin preliminary design.

- 5. Final Applications due to ADOT TSS by COB December 18, 2024
- 6. Safety Review Committee will convene and rank/prioritize all applications by February 16, 2025
- 7. Final list of eligible projects submitted to PRB on March 18, 2025
- 8. Final list of eligible projects submitted to State Transportation Board on April 18, 2025
- 9. Eligibility/Award letter sent out to sponsoring agencies after approval of project by State Transportation Board
- \* Any HSIP application received after the deadline will not be processed. Please ensure that when applications are submitted to ADOT that the projects are placed in the associated COG/MPO TIP "Parking Lot" so that, if eligibility is approved, it can be added to TIP before the submission of the Project Initiation Request Letter to the ADOT LPA Section. If a Project Initiation Request Letter is received and the project is not programmed in the corresponding TIP, it will be returned unprocessed at the risk of the LPA not having it submitted before the deadline.

As with previous years, HSIP eligibility will be based on the minimum benefit to cost ratio at or above 2.5. Only fatal and suspected serious injury related crashes will be considered correctable. All state and local projects will be selected on the same funding levels with priority going to the projects with the highest benefit to cost ratios.

Because of the time between application and funding, ADOT strongly encourages applicants to consider low cost temporary safety countermeasures as interim safety treatments where such countermeasures exist and are practical to deploy.

Below is the link to the HSIP Manual, application and Appendixes updated 2023. Ensure that all HSIP applications submitted to ADOT are on the updated application form. If any application is received on a previous form, the application may be returned unprocessed.

If you are an LPA, all HSIP applications must be submitted through your COG/MPO or the application will not be considered. This will ensure that each project will appropriately be considered at the COG/MPO level before submission to ADOT. This will also ensure the ability for the projects to be placed in the associated TIP "Parking Lots" required for consideration. COG/MPO and State agencies must submit all applications to the HSIP Program Manager. In addition, ADOT strongly encourages applicants to contact ADOT staff for questions or application review prior to final submission date.
