- FY25-26 HSIP Applications: Greenlight has completed draft applications of the four (4) FY25-26 HSIP projects previously approved by the TAC and Executive Board. Draft applications are ready for preliminary submittal to ADOT once ADOT announces the call for FY25-25 projects, which is expected sometime in January 2022.
- Rural Summit: The LHMPO staff attended along with Chairman Cal Sheehy. Greater Arizona
 came together and presented individual projects for each region and as a state-wide project to
 various state legislators in an effort to secure 2022 legislative set-aside/appropriations funds.
- Distracted Driving Campaign: Starlite has finished the final video of the distracted driving campaign. The final video was initially 90 seconds long; however, we decided to edit the footage and chop it into three (3) separate 30-second videos. One 30-second video will be released over the next three months, November, December, and January. A new video will be released each month on all social media sites. These final three videos complete the distracted driving campaign project for the LHMPO.

SUMMARY/BACKGROUND:

As sub-recipients of federal funds, the Lake Havasu MPO is required to adhere to the federal regulations and federal procurement code; however, the LHMPO must also adhere to the Arizona Department of Transportation (ADOT) Work Program Grant Agreement (contract), which requires compliance with the state procurement code. i.e., the Lake Havasu MPO must follow a hybrid Federal/State procurement code and comply with various regulations depending on certain circumstances.

Adhering to both Federal & State Procurement Codes has caused confusion; the Lake Havasu MPO Procurement Policy establishes clarification and procedural guidance on which rules apply.

A few points of clarification:

- 1. This policy in no way suggests changes to City practices. The LHMPO will still follow City processes and use required forms to register vendors/contractors into Oracle's Requisition/PO payment system.
- 2. This policy is a hybrid of State & Federal compliance; we are already following a majority of federal regulations, except for areas in which the LHMPO/ADOT contract calls for adherence to State code (e.g., travel rates)
- 3. Exhibit A "LHMPO Procurement Methods at a Glance" is a simple two-page summary of procurement thresholds, required approvals, solicitation requirements, and documentation requirements.

The draft policy was submitted to ADOT for review and preliminary approval. I am happy to announce that the LHMPO received a stamp of approval and support from ADOT's Contract & Procurement Compliance Manager (Dr. Sally Palmer).
