Vice-Chairman Steven Latoski motioned to approve the Transportation Improvement Program (TIP)-FY22 Amendment #1. The motion was seconded by Jeff Thuneman.

#### 7. Surface Transportation Block Grant (STBG) - FY22 Loan #1

Justin Hembree, LHMPO Director, recommended to the TAC a loan from the LHMPO to ADOT. The FY2022 Loan #1 will loan out all lapsing funds in STBG with the repayment in F.Y. 2023.

Roland Hulse motioned to approve the Surface Transportation Block Grant (STBG)-FY22 Loan #1. The motion was seconded by Jeff Thuneman.

#### 8. Highway Safety Improvement Program (HSIP) - Call for FY25-26 Projects

Justin Hembree, LHMPO Director, presented ADOT's revised call-for-projects timeline for the FY25-FY26 Highway Safety Improvement Program (HSIP). The Draft applications are due to the local agencies for review and comment between March-May. After the local agencies review the Draft applications, Greenlight T.E. and or the LHMPO will submit them to ADOT by May 31 for preliminary review and comments. ADOT will provide comments and feedback to the local agencies by June 31 to allow for final revisions. All Final applications are due to the LHMPO by July 25, and the LHMPO will submit the final applications to ADOT by the August 1 deadline.

Mike Blankenship, Greenlight T.E. reviewed the 5 HSIP applications with the TAC. Mr. Blankenship explained that applications #1 State Route 95 & #3 Swanson Ave have no issues moving forward. However, application #4 Horizon 6 requires additional justification language regarding paved shoulder widths. Application #2 McCulloch Blvd. needs to be revised due to pavement/resurfacing no longer being an eligible HSIP activity; An alternative application for a systemic speed feedback project was recommended in its place. The City agreed that a systemic speed feedback signing project for several major city routes (Acoma, McCulloch, Kiowa, Palo Verde) was needed and gave Mike Blankenship and the LHMPO the verbal "go-ahead" to develop the application.

Mr. Hembree announced that an additional application (#5) was added to the list for a "Traffic Signal Warrant Study" and is pending an ADOT eligibility response. The study will be administered and managed by the LHMPO if awarded.

#### 9. ADOT District Engineer's Report

Todd Steinberger, P.E. Northwest Assistant District Engineer, stated that ADOT would continue to work with LHMPO for the ITS items on the signals. In addition, Mr. Steinberger reported that the corrections labor force clean-up continues in the

Lake Havasu City area. Also, handrail improvements are being made in multiple locations in Mohave county.

Following Mr. Knudson's comment, Mr. Steinberger stated ADOT is anticipating a second clean-up crew if eligible inmates are available.

#### 10. ADOT Planner's Report

Jason James, Transportation Planning Program Manager, provided the following update:

#### 1. ADOT FY23-27 Tentative Five-Year Transportation Facilities Construction

**Program:** ADOT has released its' tentative 2023-2027 Five-Year Transportation Facilities Construction Program for public review and comment. The public comment period for the Tentative Five-Year Program ends on June 2, 2022. The State Transportation Board will consider final formal action on the Five-Year Program at its's June 18 board meeting. 3. Mr. James introduced his replacement, the new ADOT MPD Planner for the Lake Havasu region, William (Will) Randolph. Mr. Randolph will become the ADOT MPD voting member for the LHMPO TAC moving forward.

Roland Hulse, WACOG Transportation Manager, provided an update on the WACOG Transportation Implementation Plan and survey. In addition, Kittelson and associates are finalizing the Regional Demand Analysis, which should be available in mid-April.

#### SUMMARY/BACKGROUND:

Title VI of the Civil Rights Act of 1964, the Americans with Disabilities Act (ADA), and other nondiscrimination laws and authorities, prohibits discrimination on the basis of of race, color, national origin, sex, age, or disability. ADOT, FHWA, and FTA require a Title VI-Nondiscrimination Plan from each recipient of federal transportation funding within the state of Arizona. The Lake Havasu MPO Title VI Plan ensures fair treatment and meaningful involvement of all people during the planning, development, evaluation, and implementation of Federal-aid programs and activities.

In addition, ADOT also requires an annual report indicating the current year's public involvement, modifications made to the Title VI Plan, and the upcoming year's goals.

The following is a brief description of Title VI activities during the fiscal year 2022:

- 1. Lake Havasu MPO did not receive any Title VI complaints during FY 2022
- 2. The annual Title VI Plan has been updated, FY 2022 updates are located in Exhibit E at the back of the Plan
- 3. The FY 2022 Annual Title VI Report is complete and attached to this memorandum.

#### SUMMARY/BACKGROUND:

This memo outlines the amendments necessary to the FY2021-2026 LHMPO Transportation Improvement Program (TIP) for **FY2022 – Amendment # 2** (Consolidated Amendment includes Subsections 2.1-2.2)

In recent weeks, a fatal crash occurred at the intersection of McCulloch Blvd. and Jamaica Blvd; This intersection is in the vicinity of an existing Highway Safety Improvement Program (HSIP) Signal Project at Swanson Ave. & Acoma Blvd (T0344). At the City's request, the Lake Havasu MPO reached out to ADOT Traffic Safety Section (TSS) to enquire about the possibility of transferring the HSIP funds from the Swanson Ave. & Acoma Blvd. intersection and reallocating them to install a traffic signal at the McCulloch Blvd. & Jamaica Blvd intersection.

ADOT TSS requested that an updated 5-year crash history and benefit-cost ratio (B/C) analysis be conducted for both intersections. Greenlight Traffic Engineering performed this analysis; please see the attached email correspondence #1 and analysis figures as justification. Based on the analysis, all agencies agree that McCulloch Blvd at Jamaica Blvd. is the most appropriate intersection to allocate HSIP funds and install a signal.

Per the second attached email correspondence, ADOT TSS agreed to the reallocation of HSIP funds from one intersection to another.

However, they requested that Lake Havasu City and the LHMPO:

- 1. Cancel the Swanson/Acoma Signal Project and remove it from the LHMPO TIP
- 2. Submit a new HSIP project application and signal warrant report for the proposed signal at the McCulloch/Jamaica intersection and add the new project to the LHMPO TIP.

The following TIP amendments are necessary to address ADOT Traffic Safety Section's request:

#### FY2022 – Amendment # 2.1 – Formal

The following outlines necessary/proposed changes to the TIP:

#### Recommendation:

Delete HSIP project "LHM-18-108D" from the TIP:

Based on the 5-year crash data and updated benefit cost (B/C) ratio. The proposed signal at Swanson Ave / Acoma Blvd is no longer warranted.

The LHMPO collaborated with Greenlight Traffic Engineering to complete an HISP project application and traffic signal warrant analysis for the McCulloch Blvd / Jamacia Blvd intersection. Attached you will find Greenlight TE's full report. Here are findings from the analyses ADOT requested to help them determine next steps:

- **Acoma/Swanson** (1 serious injury crash at this intersection in the last 5 years, compared to 7 serious injury crashes in original application)
  - o Full project with signal: B/C is 0.6
  - o Full project without signal: B/C is 1.6
  - o Project with only a signal: B/C is 0.2
- Jamaica/McCulloch (1 serious injury and 1 fatal crash at this intersection in the last 5 years)
  - Full project with signal: B/C is 3.9
     Project with only a signal: B/C is 4.4

For cost estimate of new signal, I used the\$750k estimate from the Acoma/Swanson signal estimate and \$250k for other improvements on Acoma and McCulloch near El Dorado, \$1 Million total.

#### Good Afternoon All:

Based on the evaluation provided below, Mona has advised me that it is OK to go ahead and cancel the signal at Swanson and Acoma and utilize those HSIP funds to install a signal at McCulloch Blvd & Jamaica Blvd. Since the signal design and construction is the majority of work on the project, it has been determined that it is best to cancel T0344 and create an entirely new project.

In order to cancel T0344 and initiate a new project, ADOT will need the following to be accomplished:

- 1. A signed letter from the City cancelling T0344 with the justification. The letter will need to be signed by the Assistant City Engineer or the individual authorized to sign for him. This requirement is because the Assistant City Engineer is the individual who signed the application requesting the federal-aid funds and is the individual who the HSIP eligibility letter is addressed to.
- 2. A new 2019 HSIP application will need to be submitted to ADOT TSS (anticipated cost not to exceed the amounts in T03444) with the signal warrant for the new signal as an attachment.
- 3. After a new HSIP eligibility letter is provided, the LHMPO TIP will have to be amended.
- 4. A new Project Initiation Packet will need to be submitted to the ADOT LPA Section.

Keep in mind that the goal for having a completed JPA in place for the SFY23 design phase is July 2022, so the schedule is going to be tight.
