3. Roll Call-(Sarah Lojewski)

The Roll Call was performed by Sarah Lojewski

Present: Chairman; Cal Sheehy, Vice Chairman; Buster Johnson, Secretary/Treasurer; Nancy Campbell, and Board members Jeni Coke. Board Member Gary Knight was present after roll call.

4. Call to the Public

There was no request to address the Board.

5. Meeting Minutes: August 08, 2023

Secretary/Treasurer Nancy Campbell motioned to approve the August 08, 2023, Meeting Minutes. Vice Chairman Buster Johnson seconded the motion.

6. Traffic Signal Analysis & Modeling Study - Request For Proposals

The LHMPO TAC received and reviewed three proposals in response to the MPOs RFP solicitation. The three firms where: Kittelson & Associates, Greenlight Traffic Engineering, and Kimley-Horn & Associates. The TAC unanimously ranked Kimley-Horn as the top firm. Jeni Coke motioned to approve Kimley-Horn as the top firm/consultant, the LHMPO to proceed with the contract negotiations, and the MPO chair to initiate the contract. Vice Chairman Buster Johnson seconded the motion.

7. RTAC Project for Legislative Session 2024

The list comprised of projects for Greater AZ totaling \$400 million will be introduced to the state legislators as a *single* piece of legislation (bill) or may simply be included in the Governor's budget. Based on the table and figures provided by the Rural Transportation Advocacy Council (RTAC), the overall anticipated funding available to the LHMPO region is estimated at \$14.2 million. The LHMPO worked with the locals to identify projects for the 14.2 million they identified four projects. Facts sheets for each project have been finalized and are included in the agenda packet.

Secretary/Treasurer Nancy Campbell motioned to approve the RTAC projects for the Legislative Session 2024. Vice Chairman Buster Johnson seconded the motion.

8. Transportation Alternatives (TA) Call for Projects

Justin Hembree, LHMPO Director advised the Executive Board on the safe routes to school scoping grant application submitted by the LHMPO requesting \$400k in federal grant funds; the scoping project lists 8 locations comprised of elementary, middle, and high schools. The LHMPO is expected to receive the award or non-award notification from ADOT by the end of October.

9. Rural Transportation Advocacy Council (RTAC) Report (Information Only)

Kevin Adam, RTAC Executive Director – Mr. Adam provided state and federal legislative updates.

10. ADOT District Report (Information Only)

Todd Steinberger, P.E. Northwest Assistant District Engineer the ADOT district advised the Board on the upcoming projects in the region.

To whom it may concern:

This letter serves as Lake Havasu Metropolitan Planning Organization's (LHMPO) formal call for "Carbon Reduction Program Funding" projects.

Program Background:

The CRP funding is a federal-aid highway funding program that funds projects designed to reduce transportation emissions, defined as carbon dioxide (CO2) emissions from on-road highway sources. Eligible projects included, but not limited to, the construction, planning, and design of on-road and off-road trail facilities for pedestrians, bicyclists, and other non-motorized forms of transportation. In addition, advanced transportation and congestion management technologies such as; Deployment of infrastructure-based intelligent transportation systems, capital improvements and the installation of vehicle-to-infrastructure communications equipment; replacing street lighting and traffic control devices with energy-efficient alternatives; projects to establish or operate a traffic monitoring, management, and control facility or program.

Funding Availability and Eligible Projects:

The following table provides the LHMPO area apportionment figures based on IIJA formula funding (based on population) and status of the LHMPO's CRP balance:

Annual Apportionment *OA	\$ 118,565.21
Currently available in FY24	\$ 329,947.97
Available in FY25 if all funding carried forward	\$ 448,513.01

The LHMPO has created a new section in the Transportation Improvement Program (TIP) specifically for the CRP funding. In order for projects to be programmed in the TIP for this specific funding source, formal TIP amendments will be required at the TAC and Executive Board levels.

- Port congestion reduction

Funds can be used for any STBGP-eligible use if the state/MPO can demonstrate a reduction in transportation emissions.

Due Dates and Timeline:

The LHMPO respectfully requests that agencies fill out the attached project application and return to LHMPO by **Friday**, **March 15**, **2024**.

The Call for Projects and funding will be discussed at the LHMPO Transportation Advisory Committee (TAC) meeting on **November 14, 2023** and the Executive Board meeting on **December 12, 2023**.
