A RESOLUTION OF THE EXECUTIVE BOARD OF THE LAKE HAVASU METROPOLITAN PLANNING ORGANIZATION, MOHAVE COUNTY, ARIZONA, APPROVING THE REVISED LHMPO STRATEGIC TRANSPORTATION SAFETY PLAN AND COMMITMENT TO VISION ZERO

WHEREAS, the Lake Havasu Metropolitan Planning Organization (LHMPO) is committed to improving transportation safety for all users within its region; and

WHEREAS, the LHMPO approved a Strategic Transportation Safety Plan on April 8, 2025, which identifies key safety issues, sets measurable goals, and implements effective strategies to reduce serious injuries and fatalities on the transportation network; and

WHEREAS, the LHMPO wishes to revise the Strategic Transportation Safety Plan to establish a clear objective to "achieve a 5% annual reduction in serious injury and fatal crashes until reaching zero fatalities or serious injuries within the LHMPO region, supporting the broader national and global movement known as Vision Zero; and

WHEREAS, the LHMPO Executive Board recognizes that implementation of the LHMPO Strategic Transportation Safety Plan is essential for creating a safer, more equitable, and more efficient transportation system for all roadway users.

NOW, THEREFORE, BE_IT RESOLVED by the Executive Board of the Lake Havasu Metropolitan Planning Organization, Mohave County, Arizona, as follows:

<u>Section 1</u>. That the LHMPO Strategic Transportation Safety Plan is revised as shown on the Attached Exhibit "A" to include the goal of achieving a 5% annual reduction in serious injury and fatal crashes until reaching zero fatalities or serious injuries within the LHMPO region.

<u>Section 2</u>. That the LHMPO Executive Board commits to incorporating the principles and strategies of Vision Zero into its planning, programming, and policy-making processes, with the shared purpose of eliminating traffic-related deaths and serious injuries.
